

# Why The Law Is So Perverse

I am a fan of all of Leo Katz's books -- you can learn more from each page of this then many casebooks combined. Despite the engaging and entertaining style of the book, it is a deep and important work of legal theory. Very roughly, Katz argues that the often strange structure of the law has more to do with Arrow's impossibility theorem then people have realized. Its an important idea and he delivers it in a very readable and enjoyable way.
