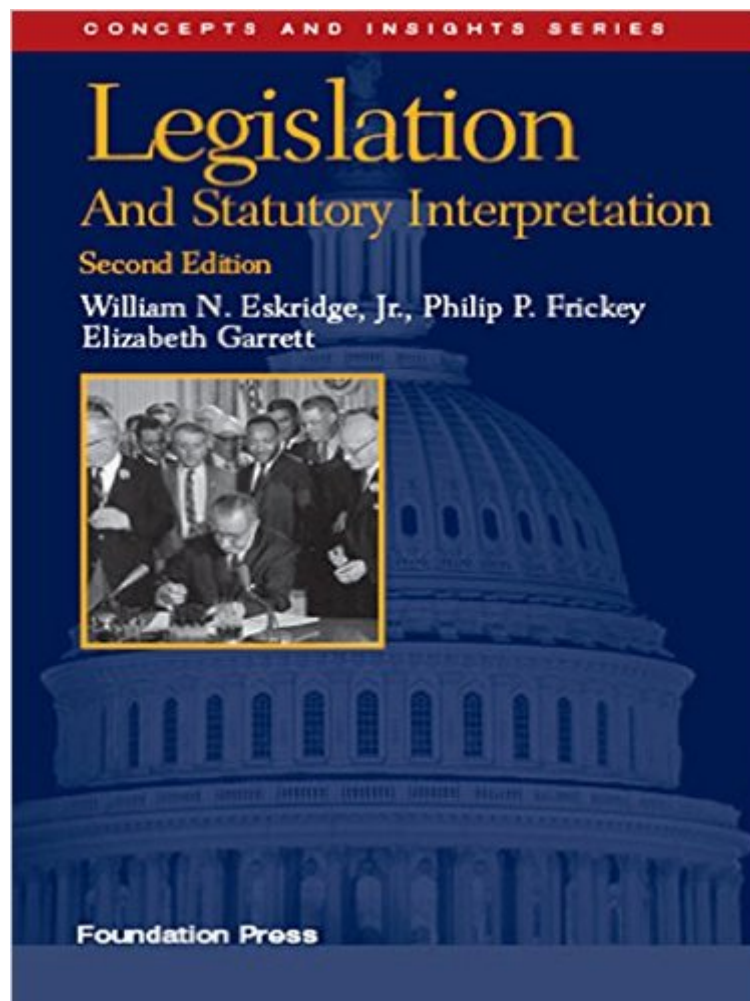

This book covers the same material in the casebook, but in a much more straightforward, easy to read fashion.
