

This review relates only to the Kindle version. offers no way to separate the reviews of the digital and print editions. Presumably, think the two copies should be considered identical. Unfortunately that is not the case. The kindle version is faulty. Like some similar books, the flowcharts and tables have been scanned at a horrifically low resolution, such as to make them effectively unreadable. With this book, they've gone one step further though. All the charts have been scanned in sideways. Yes, to try and make out what the low resolution image says, you're expected to tilt your head to 90 degrees if using the PC App or Cloud reader. If you're using an iPad, you'll need to disable the auto-rotation function. My advice, buy the print copy.

I bought this little book the day before my evidence final. Our class wasn't particularly awesome--it was the prof's first time teaching, and although he understood evidence, he wasn't great at explaining it. In less than 24 hours, this book clarified every concept that I didn't yet understand. The capsule summary is the main part of this book, and it is great. There are SO many examples to clarify the many abstract applications of the Federal Rules of Evidence! You can't HELP but understand it! There are some really cool flowcharts in the front that take you through the complete analysis for hearsay, best evidence rule, and a couple other things. It also has practice questions (though I didn't have time to use them).

These flowcharts are helpful as I'm cramming for my Evidence final right now. However, the Kindle version of this book has several of the charts sideways, which is annoying. Some of the charts are rather poorly scanned into the Kindle version as well, so the font is not clear. Viewing them from my computer is easier, and I can rotate the view, but I was really looking for a handy study guide for my Kindle. I'd recommend just buying the print version of this book.

This review relates to the Kindle version of Emanuel's CruchTime for Evidence. As noted in previous reviews, the flow charts are scanned in sideways, but you can easily fix this problem by locking your screen to stop the automatic rotation and you can easily see the flow charts at that point in the "landscape" version of the screen. This book goes very in depth and makes a difficult topic to learn in a lecture style classroom much easier to understand. The Kindle version makes it much easier to take the book with you when you are traveling or waiting in doctor's offices when you want to grab a few extra minutes to study. The only real problem I have with the Kindle version of this book is that even if your professor is using an open-book format for your final exam, you probably won't be allowed to take your Kindle into the exam since you can access the internet from the device. All in all, this is a great book and I love having a version that is on my mobile device that I carry constantly, and much less bulky than carrying around hard covers of all my study aids.

This is a great tool to help you study. Includes concepts that are commonly tested, sample test questions, flowcharts, and a nicely organized, fairly detailed outline of the main rules of evidence. Not incredibly detailed, but good for those who already have a grasp of the material and want to quiz themselves and gauge their understanding of broad topics.

The book arrived quickly and in good condition. Evidence, as other books in this series, provides a concise and logical flow to the material. They provide a great summary to the usually dry casebook and hornbook materials typically used in legal education!
